## 3. NEW – 2020 CENSUS CHANGES IN MICHIGAN URBAN AREAS – Jane Fitzpatrick

From the Michigan Center for Data and Analytics:

After each decennial census, the U.S. Census Bureau conducts a review of the criteria for delineating urban areas and may update this criterion to more effectively tabulate and present data for the urban and rural population in the United States.

The new 2020 Census criteria for urban areas now requires a minimum population of 5,000 people or 2,000 housing units. This differs from the 2010 Census criteria for urban areas, which solely required a minimum population of 2,500 people.

The finalized list of 2020 Census urban areas was released last month. As a result of the change in the urban classification between 2010 and 2020, Michigan added four new places to its list of "urban areas", three of which are in the EMCOG Region: **Au Gres, Higgins Lake**, and **St. Helen**. Frankfort is the fourth new urban area.

However, there were 28 Michigan places which were urban under 2010 criteria, but no longer urban under 2020 criteria (i.e., places that changed from urban to rural status). Five of these places are In the EMCOG Region: **Bad Axe, Clare, Gladwin, Sandusky**, and **Vassar**. The remaining 23 are Almont, Blissfield, Brooklyn, Cedar Springs, Constantine, Coopersville, Dorr, Fowlerville, Goodrich, Grayling, Gun Lake, Hart, Imlay City, Iron River, Kalkaska, Manistique, Middleville, Munising, Newaygo, Newberry, Perry, Rogers City, and Somerset.

# 5. **UPDATE** – ECONOMIC RESILIENCE DATA: RECOVERY STRATEGY ADDENDUM – Cynthia Edwards

Post COVID-19 data is a consolidation of reporting from various agencies and sources, but it is not official census data. Being an unprecedented global event, we are still trying to interpret the data as best as we can. This data will be presented as an appendix to the official report, as this event was an extreme outlier and requires additional analysis. We are tracking significant demographic shifts that are outside what would normally be expected and can be traced directly back to COVID-19. These changes are happening at a pace that would not be expected in a typical 2-year snapshot of comparable data.

The impacts are not uniform. There are contrasting effects being felt through different industries, some have thrived, some have struggled substantially. There are notable differences on severity in individuals based on economic class and/or race. The data we are compiling and will continue to present will help you identify industries and individuals with the highest needs.

The COVID situation is still very fluid, and information is still coming in daily. We will continue to update your resources for the region as it is received.
