# 3. **UPDATE** – GRANT: CONNECTING DISCARDS, REUSE, AND STEM – Jane Fitzpatrick

As reported in July EMCOG is a recipient of a grant funded through the CERI (Comprehensive Economic Recovery Initiative) supplemental grant awarded to the EDA REI University Center at the MSU Center for Community and Economic Development. The scope of the grant is to conduct research to determine opportunities for diversion of discarded materials used in the built environment and in the manufacturing process in the region. There are a number of partners for this initiative that will be providing support for the work.

Work has begun and a survey will be available soon, if not by the time you read this report. There are actual two surveys to choose from: one for users of discarded materials and one for generators of those materials. An in-person workshop to talk about the survey results plus resources and next steps is scheduled for November 2<sup>nd</sup> (time and location to be determined).

### 4. **REMINDER**: EMCOG EDA CARES ACT 14 COUNTY REVOLVING LOAN FUND – Jane Fitzpatrick

EMCOG received funding in July, 2020 from the U.S. Department of Commerce EDA to establish a 14-County Revolving Loan Fund (RLF) through the CARES Act. The allocation to EMCOG included approximately \$500,000 for lending for projects which promote business revitalization and growth, enhance workplace safety, strengthen supply chains and sustain and/or create jobs.
