### 3. NEW – ECONOMIC RESILIENCE: RECOVERY STRATEGY ADDENDUM – Cynthia Edwards

Post COVID-19 data is a consolidation of reporting from various agencies and sources, but it is not official census data. Being an unprecedented global event, we are still trying to interpret the data as best as we can. This data will be presented as an appendix to the official report, as this event was an extreme outlier and requires additional analysis. We are tracking significant demographic shifts that are outside what would normally be expected and can be traced directly back to COVID-19. These changes are happening at a pace that would not be expected in a typical 2-year snapshot of comparable data.

The impacts are not uniform. There are contrasting effects being felt through different industries, some have thrived, some have struggled substantially. There are notable differences on severity in individuals based on economic class and/or race. The data we are compiling and will continue to present will help you identify industries and individuals with the highest needs.

The COVID situation is still very fluid, and information is still coming in daily. We will continue to update your resources for the region as it is received.

### 4. UPDATE – GRANT: CONNECTING DISCARDS, REUSE, AND STEM FINDINGS WORKSHOP ON November 2nd – Jane Fitzpatrick

As reported in July EMCOG is a recipient of a grant funded through the CERI (Comprehensive Economic Recovery Initiative) supplemental grant awarded to the EDA REI University Center at the MSU Center for Community and Economic Development. The scope of the grant is to conduct research and a survey to determine opportunities for diversion of discarded materials used in the built environment and in the manufacturing process in the region. An in-person workshop to talk about the survey results plus resources and guest speakers and a discussion of next steps is scheduled for November 2<sup>nd</sup> at from 10:00 to 11:30 am at the Midland Campus of Delta College.
