Call to order, Welcome and Introductions: Robert Balzer, RED Team Chair The meeting was called to order by Chair Robert Balzer at 12:04 pm. RED Team members.

Guests and staff introduced themselves. Bob welcomed the 2021 appointed members of the RED Team noting that the EMCOG Council Chair had made the appointments at the 10:00 am Council meeting. He read off the names of the 36 appointed members and noted that there is now representation from all fourteen counties of the region.

2. Review and Approval of Agenda (action item)

Jim McBryde made a motion to approve the agenda as presented; supported by Natasha Allen. The agenda was approved with no changes.

3. Review and Approval of November 6, 2020 RED Team Minutes (action item)

The motion to approve the minutes was made by Zyggy Dworzecki and supported by Kathy Methner. There was no further discussion and the minutes were approved with no changes.

4. Chairperson Update: Robert Balzer

Bob noted that it has been a privilege to work with TIP Strategies, Inc as well as EMCOG over the last few years. The work involved in developing a new CEDS is very important and noted the incredible participation from across the Region. Bob gave a shout out to the MMDC and SFI for all of the work that they have been doing being the scenes to get out the small business survival grants. He also acknowledged Consumers Energy regarding their Our Town grant funds program which resulted in \$9,000 in Gladwin County for a 1 to 1 match for businesses. And finally he noted that with all that we've been going through, it is nice to hear Tim Allen's voice again with the return of Pure Michigan.

Jane reviewed the process of when we started and how we got to this point of approval of the 2021-2025 CEDS for submittal to the Department of Commerce, Economic Development Administration (EDA) by January 31, 2021 for review and approval. She noted that there were a few changes to the draft CEDS based on comments received during the public comment period. These changes were sent to the RED Team prior to this meeting and Jane reviewed them with the RED Team at this time. The motion was made to approve the CEDS as amended per the proposed revisions. The motion was supported with 27 yes and 0 no votes.

There was a facilitator for each group and a worksheet to steer

the discussions around strategy implementation including what can be done within the first 60 days (i.e. by the next RED Team meeting in March). Each facilitator reported back to the group as a whole. Jane will be compiling the group discussions into the start of an implementation matrix to be a regular agenda item for the RED Team meetings moving forward.
