3. Implementation of Career Planning Utilizing An OnlineTool - - Lori Flippin, STEM Initiative Leader, GLBRA

Lori Flippin provided a power point presentation of the results of a 2017 RPI-5 grant award to the Great Lakes Regional Alliance to utilize *ccinspire*, a component of Career Cruising, to bring career decision makers and local employers together to help individuals achieve their career goals and address the workforce development needs of our region. The GLBRA requested and was granted extensions of the grant timeframe along with a 50% reduction in the benchmarks during 2018 and 2019. The benchmarks have now been achieved. A copy of the power point presentation will be distributed.

Brian inquired about changes coming out of the WAMC guidelines and how they would handle plans that are already in progress. The County recently finished the 4 year transit and transportation plan for federal requirements and is now starting to work on the Saginaw County Non-Motorized Plan.

Chris Rishko, GLB Michigan Works

Chris gave an update on MiCareer Quest coming up on October 30th. – to date there are 84 employers registered for exhibits and 9,800 students registered to attend. Chris thanked EMCOG and PR-5 for approving a grant for transportation to the event. SVSU is all set for the event venue, the exhibitors are holding planning sessions for great ideas of what to bring including a virtual reality suite. The Governor's Office will be invited.

Kathy Methner, Consultant

Kathy gave an update on the 2018 RPI-5 grant for the Arenac County Fairgrounds Relocation project. They are now in the design phase for the entrance and will be closing on the property in January. The RPI-5 grant covered the engineering costs for the entrance. Regarding the RPI-5 \$1,000 grant for the fairgrounds sound system: the system was purchased but not yet installed. Kathy also gave an update on the EDA funded City of Beaverton Industrial Park grant. She will be going to Chicago with the City next week in preparation for the project start-up. Kathy also thanked PR-5 for the 2019 grant funding support for projects in Gladwin County.

Stephanie Buffman, Arenac County EDC and Michigan Works Region 7B

They recently closed on a parcel near the City of Au Gre for the Iron Bell Trail. They are looking for other funds for this initiative.
