Eric Johnson, Clare-Gladwin RESD

Natasha Allen, Michigan Works Association

Natasha is now the director of training for the Association and encourages all to become an association member. She encouraged those at the meeting to look at the trainings offered which are centered around workforce development and not all services are training related.

Brenda Bachelder, Roscommon EDC and MIWorks Region 7B

They are partnering with the GLB Michigan Works MICareerQuest on October 28th at SVSU. They will be focusing on the same careers as last year; 4,700 students registered from 11 counties with a focus on 10th graders. This program helps kids stay local. https://micareerquestmm.com/

Meaghan Gass, MSU Extension, Michigan Sea Grant

Meghan mentioned the Community Education Programs and referenced the https://www.michiganseagrant.org/ website for watersheds in your district resources. They are funding a study for looking at reefs out in the Saginaw Bay which serve as spawning grounds for Walleye.

Stephanie Buffman, Arenac County EDC

They applied for and were selected to be one of six applicants to be part of a rural childcare innovation program. They will receive \$240,000 to address this need in the manufacturing cluster in Arenac County.

Heather Bauman, The W.E.L.L. Outreach

Kathy Methner, Roscommon County EDC Chair and Brownfield Authority

The Roscommon County EDC has received ARPA funding from the County. This funding will include a grant program for small businesses.
