1. Call to order, Welcome and Introductions: Bill Mrdeza, Chair pro tem

Note – RED Team Chair, Bob Balzer was unable to attend the meeting. The meeting was called to order at 12:04 pm with introductions of those present. 2. Review and Approval of Agenda

The agenda was approved as presented.

- **3.** Review and Approval of September 11, 2020 RED Team Minutes The draft minutes were approved with no changes.
- 4. Chairperson Update: Bill Mrdeza, Chair pro tem There was no chair update.
- 5. Four Lakes Task Force Report on May, 2020 Disaster Status: Dave Kepler, President & Joel Vernier, Board Member

The Four Lakes Task Force is a 501(c)(3) nonprofit organization managed and operated by lake residents and industry experts to administer and oversee the maintenance and operations of the four dams and lakes of Secord, Smallwood, Wixom and Sanford in Gladwin and Midland counties.

Dave Kepler gave a brief background of the dams pre-disaster noting that there are not many Federal programs that cover private infrastructure. The burden of costs of maintenance comes to the lake property owners. The four lakes encompass nine townships and villages with 8,000 parcels with 6,000 property owners. The first step for restoration and stabilization is to acquire the dams. The current owner does not have the resources to repair, address environmental and restoration needs. The FLTF hopes to get the property by the end of this year. The estimate to just stabilize the system is \$40 Million. Further steps include getting through the stabilization phase, then conducting flood studies regarding flood capacity and what needs to be changed; then design, engineering and rebuilding all four dams. It will take a significant amount of money to bring the four dams up to current standards with an optimistic time frame of 3-5 years.

6. Back to Michigan - Great Lakes Bay - Katie Mora, Middle Michigan Development Corporation This is the third annual Coming Home event. EMCOG provided financial support through the RPI-5 grant initiative for the first event two years ago. Due to the pandemic, it will be a virtual event this year (November 23rd). Katie will tell us how this virtual event will connect participants with organizations including one-on-one chats. <u>http://discovergreatlakesbay.com/coming-home/</u>

This year is the third year of this event It will be a virtual event for this year. The event is a networking event which was held at SVSU in 2018 and Mountaintop Station in Mt Pleasant/CMU in 2019. Young professionals are invited back to the area. The rimary goals include connecting job seekers with jobs and networking. A website has been launched covering the eight counties of Regional Prosperity 5 region. Also this initiative will be hosting two booths at the Back to Michigan virtual event later this month.

7. Integrated Economic Development Activities: EMCOG Staff (highlights of written reports sent out prior to the meeting).

Staff gave summaries of previously distributed written reports. Jane provided additional comments regarding COVID-19 in the Region: as of November 5th: there were 11,842 confirmed cases (3.7% increase from the day before) and 369 confirmed deaths. We are seeing spikes in Bay and Clare counties this week.

8. Good of the Order

Jim McBryde, Middle Michigan Development Corporation

Jim gave a report on the distribution of State resources relating to the pandemic : MEDC CDC Council distribution: Saginaw Future Inc. distributes funds for the counties of Saginaw, Bay, Arenac and Midland.Sag Future (sag/bay/arenac/midland. Middle Michigan Development Corporation

(MMDC) distributes funds for the counties of Gratiot, Isabella, Clare and Gladwin. – MMDC distributes \$200,000 in March and April through 170 grants at an average of %5,000 per grant. November 6, 2020 Page 3 of 3
